## “OSHA Update: Is your office in compliance with Current Guidelines?”

Linda Borowski, RDH is a local and state recognized speaker and consultant on dental office OSHA compliance, infection control implementation, and human resource issues. She founded RDH Health Services, a dental staffing and continuing education corporation in Michigan. She graduated from the University of Detroit/Mercy School of Dentistry department of Dental Hygiene and is a member of the American Dental Hygienists Association, the Northeast Regional Board of Dental Examiners, the American Association of Dental Boards, and OSAP, the Organization for Safety, Asepsis and Prevention. She has held elected positions in the Michigan Dental Hygiene Association and the Macomb Dental Hygiene Society. She was appointed by the Governor of Michigan to serve on the Michigan Board of Dentistry. Linda has received awards from the University of Detroit Mercy, MDHA and Macomb Dental Hygiene Associations and has been recognized by the Detroit and Oakland County Dental Hygiene Associations for her contributions to the profession. She received the National Association of Women Business Owners' award for Top 25 Women Business Owners.
