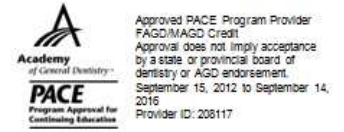

She completed her specialty training at the University of Michigan where she published her Master's thesis in Early Childhood Caries and was a Mott Fellow at Hurly Medical Center. In 2007, she became a diplomate of the American Board of Pediatric Dentistry as well as a fellow of the American Academy of Pediatric Dentistry. Dr. Tiberia has joined the staff of Children's Hospital of Michigan and St. Joseph Mercy Oakland, where she treats patients in a hospital setting and teaches Pediatric Dentistry for the residents. She volunteers at Beaumont's Craniofacial and Cleft Lip and Palate Clinic. She is active in organized dentistry and currently serves as President of the Michigan Academy of Pediatric Dentistry.
